  - Vanessa called the meeting to order at 3:06 pm.

  - Quorum met.
- Approval of agenda
  - Allyson motioned to approved, CVAF seconded the motion, all ayes, no abstentions.
- Public comment for good of the order
  - Mardi HACK is getting ready to issue 234 emergency housing vouchers with matching occurring on 7/7/21. There will be an attempt to issue all 234 vouchers on that day. House-athon is also being planned with possibility of broadcasting the event. Email Mardi for additional information.
  - Rebecca added that to get your client housed using the EHV Mardi mentioned, please have a current SPDAT completed by the Monday before 7/7/21 to get them on the match list. Send updates as soon as possible to Joseph Aguilar at CAPK. SPDAT scores need to be 9 or higher.
  - Allyson next month is Homeless Awareness Month. Also, the Youth Homelessness Demonstration
    Program application is being worked and will be submitted in July. More info will be shared in
    tomorrow's Governing Board meeting.
  - Vanessa Kern County Veteran Stand Down is happening in October. Information will be sent out via email blast. Everything is going to be free and will include free services primarily to our homeless veterans in Kern County. Veteran Court registration will start July 1<sup>st</sup>. ElleVet Project is coming out July 5 – 7 to perform veterinary services for pets.

#### **Old Business**

- Approval of minutes from April 27, 2021 meeting
  - Mardi motioned to approve, Yury seconded the motion, all ayes, no abstentions.
- Approval of minutes from May 25, 2021 meeting
  - Allyson motioned to approve, Rick seconded the motion; all ayes, Mardi abstained.
- Tejon Tribe Letter Submission
  - Vanessa updated the committee that the Tejon Tribe Letter submission has been completed. The committee is now awaiting a response. Thank you everyone for your assistance with this endeavor.

#### **New Business**

- In-Person Meeting Update
  - Voting member agency participants need to be present in-person at committee meetings. For the REC, it is a little different because we have Session 2 where it is meant to be interactive. We are looking to see if utilizing Zoom can still be considered moving forward for Session 2.
- REC Name Change
  - The focus of this committee is growing to include diversity, equity, and inclusion and as such, the REC is requesting a formal name change to the Diversity, Equity, and Inclusion Committee.
  - Allyson motioned to approved, Mardi seconded the motion, all ayes, no abstentions.
- BIPOC and Redistricting
  - Members of the BKRHC met with other critical community stakeholders to discuss housing for Black, Indigenous, and other People of Color. We wanted to look at community wide data to see what our homeless system data is represented as it pertains to BIPOC.
- "So You Want to Talk About Race"
  - The REC is considering having a book club style discussion via Zoom on the book "So You Want to Talk
    About Race". The REC feels like this may provide another means for continuing the discussion on
    equity and provide an educational resource for any participant wanting to join. Additional
    information will be provided concerning Brown Act compliance when undertaking this activity.
- Community engagement with All of Us or None
  - The REC is partnering with Ucedrah Osby and All of Us or None and see how we can improve our
    community engagement starting on a small scale. Vanessa, Mary, and Rick were able to meet with
    Ucedrah to plan out this pilot project to see how we can improve non-COC organizations within our
    community, particularly within the homeless system. The next meeting with Ucedrah will focus
    largely on data with regular updates to the committee.

# Session 2

- Disclaimer presented on creating a safe space for having difficult conversations regarding racial equity
- The REC is trying to access additional training for our BKRHC members on DEI-related topics to ensure that our education and conversation on DEI is continual.
- Rebecca shared a personal story on her experience with racism/stereotypes and how this experience helped her realize how important the conversations surrounding DEI are for everyone.
- Mardi shared her experience seeing racial bias directed towards a friend.
- Jessica shared her experience with her own bias as a case manager when she started at BHC and the realization of how that bias affected her work and how she implemented change for herself and her staff.
